

Please note that effective 1/1/18 we will no longer be requiring or collecting waivers. Do not submit them. You will still need to get a permit from the Special Use group coordinator for your trip.

We still require the submission of a Certificate of Insurance (COI) naming the Northeastern Cave Conservancy, Inc. as additionally insured. See list below.

For groups with any minors, trip organizers are required to share the following statement with the minors's parents or guardians.

Boy Scout groups: With the elimination of the Tour & Activity Plan, Boy Scout groups will be required the also fill out the BSA NCC form-2019.pdf. Do NOT use the previous forms. The 2018 form represents the latest scout rules. (There are a number of significant changes.)
